Investment Objective

The Fund seeks high total return from alternative investment vehicles on an annual basis consistent with a high tolerance for risk.

Fund Attributes

- Diversified alternatives allocation designed to complement traditional stock-bond portfolios.
- Allocates among alternative mutual funds and ETFs using a systematic methodology.
- May improve diversification versus traditional equity and bond portfolios; diversification does not ensure profit or protect against loss.

Reasons to Invest

- Uses multiple sleeves to diversify across alternative investment styles.
- Core exposure is built from baskets of alternative funds, with a proprietary risk-managed momentum model ("Evolution") selecting leading holdings.
- Additional sleeves may include return-seeking strategies, government bond and NASDAQ-100 futures, and private funds.
- May use leverage under certain conditions.

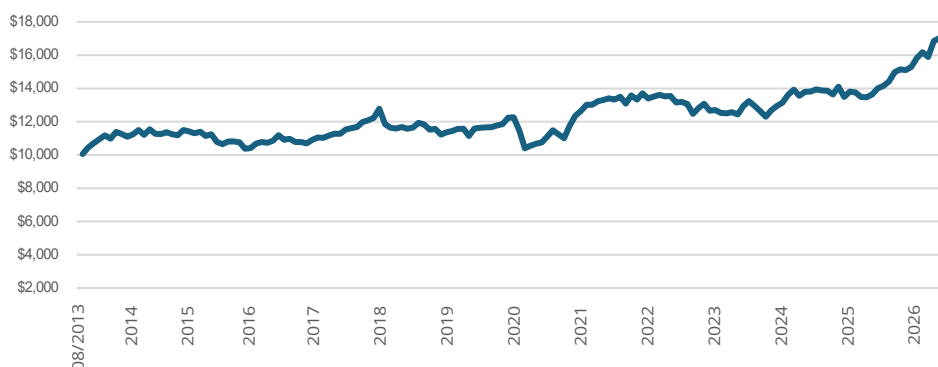

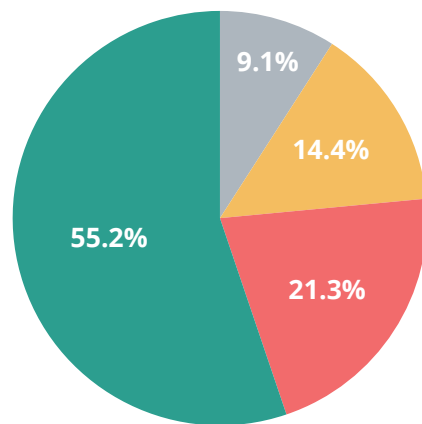

Standard Deviation: Measures the variability of returns over time.

Beta: Measures the sensitivity of the Fund's returns relative to the Fund's prospectus benchmark.

Alpha measures the difference between an investment's expected returns based on its beta and its actual returns. A positive alpha indicates the investment has performed better than its beta would predict. A negative alpha indicates an investment has underperformed, given its beta. Beta measures an investment's sensitivity to market movements. A beta greater than one indicates the investment is more volatile than the market. If beta is less than one, the investment is less volatile than the market. Standard deviation measures the range of an investment's performance. The greater the standard deviation, the greater the investment's volatility. The Sharpe ratio indicates the reward per unit of risk by using standard deviation and excess return. The higher the Sharpe ratio, the better the investment's historical risk-adjusted performance.
